**FOR TAX PURPOSES:** In order to determine the tax-deductible portion of your membership subscription, the Internal Revenue Service requires an estimate of the fair market value of benefits provided at each level of membership. After subtracting the value of these benefits, the tax-deductible portions of the Brandywine Conservancy & Museum of Art memberships are as follows:

\$500 Sponsor - \$440 deductible      \$5,000 Preservation Fellows - \$4,880 deductible  
 \$1,000 Benefactor - \$940 deductible      \$10,000 Trustees’ Circle - \$8,530 deductible

*Basic Membership* (\$40 to \$250) is fully tax-deductible.

Based on IRS rules, all members who are entitled to full deductibility for their membership subscription receive only the basic benefits of free museum admission, museum shop and café discounts, quarterly newsletter and invitations to events. The tax-deductible portions listed above reflect the value of the extra benefits available only to memberships of \$500 and higher.
